Authorization For Medical Treatment and Assumption of Risk

I understand that my child or ward may be in need of medical aid, assistance, treatment or care while at Loup Loup Ski Area and I authorize Loup Loup Ski Education Foundation to obtain, on behalf of my child or ward, all necessary medical aid, assistance, treatment or care to my child or ward by health care providers selected by Loup Loup Ski Education Foundation as a result of this Authorization.

I RELEASE and HOLD HARMLESS Loup Loup Ski Area/Loup Loup Ski Education Foundation and its board of directors, employees, agents, affiliates and insurers from any claim and/or damages which occur to my child or ward or to me as a result of any medical aid, assistance, treatment or care provided to my child or ward by health care providers selected by Loup Loup Ski Education Foundation as a result of this Authorization.

RELEASE OF LIABILITY

1. I am aware that skiing/snowboarding/tubing is a hazardous sport that includes certain risks and dangers, including the risk of serious injury or death. I voluntarily accept full responsibility for all risks involved, including risks inherent in skiing/snowboarding and in the ski area/mountain environment.
2. I accept responsibility to ski/snowboard/tube safely at all times, to abide by Your Responsibility Code, and to obey all posted behavior notices and any other ski area rules and policies. Any equipment use while skiing/snowboarding, I use at my own risk.
3. I agree to **RELEASE, HOLD HARMLESS, and INDEMNIFY** Loup Loup Ski Area and Loup Loup Ski and Board School (also known as Loup Loup Ski Bowl and Loup Loup Ski Education Foundation) and any of their employees, agents, contractors, subsidiaries, officers, board of directors, or workers from all claims for any injury or damage resulting from any cause, including negligence, which arise out of my participation in or travel to and from Loup Loup Ski Area. This release is also binding as to any other persons including all family members, heirs and executors. If I am signing on behalf of a minor, I recognize that I may not release any claims the minor may have. However, I accept full responsibility for all medical expenses incurred as a result of the minor's participation in or travel to and from Loup Loup Ski Area. I also agree to **HOLD HARMLESS and INDEMNIFY** Loup Loup Ski and Board School, Loup Loup Ski Education Foundation and Loup Loup Ski Area from any claims brought by the minor.
4. This is a binding contract that is intended to provide a comprehensive release of liability, but is not intended to assert any defenses that are prohibited by law. If any part of this contract is deemed unenforceable, all other parts shall be given full force and effect. During the course of a lesson, children/minors may ride the chair or surface lifts. He or she may be paired with a Loup Loup employee, volunteer, adult guest or may ride by themselves.

I understand and acknowledge that all sales are final and no refunds are offered.

All lessons must be completed by the end of the current season, and no lessons will be forwarded into the following season.
